
WHO SHOULD ATTEND

RENEWAL DEADLINE AND REMINDERS



DEADLINE: The deadline for submitting your school renewal and instructor renewal forms and fees is September 14, 2001. Please adhere to this deadline if your school wishes to retain approval after October 1 and/or if you plan to retain approval to teach on or after October 1.

NOTE: There is NO fee to renew schools or courses. However, administrators must complete the renewal form for your school and instructors must complete the renewal form for each course for which you wish to retain approval in accordance with the directions sent with your renewal documents.

FEES: If you teach prelicense or post license, your renewal fee is \$100. That is all regardless of what else you may teach. If you do NOT teach prelicense or post license, your renewal fee is \$50. For those who teach ONLY CE designation courses or ONLY distance education courses, there is no renewal fee but the renewal form and accompanying documents must be returned by the deadline. Please ask if you have any questions.

IMPORTANT NOTICE for Exam Applicants

Exam applicants will begin paying \$28.00 instead of \$75.00 to AMP beginning with the October exam. Please remind your students. The reduction in exam fee is due to the increase in the application fee to \$150. More explanation will be given at the Instructors' Seminar.
