

INFORMATION AND INSTRUCTIONS FOR MULTIPLE BROKER LICENSE APPLICATION

In order for you to obtain a Multiple Broker license, the following procedures will be necessary:

1. Attached form must be completed by a Broker (a Qualifying broker may serve as an Associate broker for another real estate company at the same location).
2. Please type or print all information in blue or black ink.
3. If you desire to become the Broker for two or more companies, both or all companies for which you are broker must be located at the **same address** and you must have **written consent from all companies** to operate as Qualifying Broker for two or more companies (Section 34-27-32(h)1-3 of Alabama Real Estate License Law). If an Associate Broker holding a Multiple Broker license later decides to change his/her status to Qualifying Broker, he/she must get written consent from all companies and furnish a copy to the Alabama Real Estate Commission.
4. If you are applying to be Multiple Broker for a **newly-formed company** please submit a **Company Application form** with your application.
5. Submit a check made payable to the Alabama Real Estate Commission in the amount of **\$150**.
6. Complete applications are normally processed within 3 business days from the date received. Once processed, the license will be **available for printing** by the Qualifying broker from the Commission's website using the Company login.
